These grants do not apply to students currently enrolled in accelerated, cohort, graduate, second-degree, dual Accounting/MBA students in a 5-year program, internships, or study abroad classes. Priority deadline for funds will be April 1, 2013. Final Application Deadline: two weeks prior to the start of the course.

- I am behind in my major due to being a transfer student and losing credits when transferring here. (You must have attended Bellarmine full-time for 2 concurrent semesters to be considered for this reason. Must provide a letter to explain how you are behind.)
