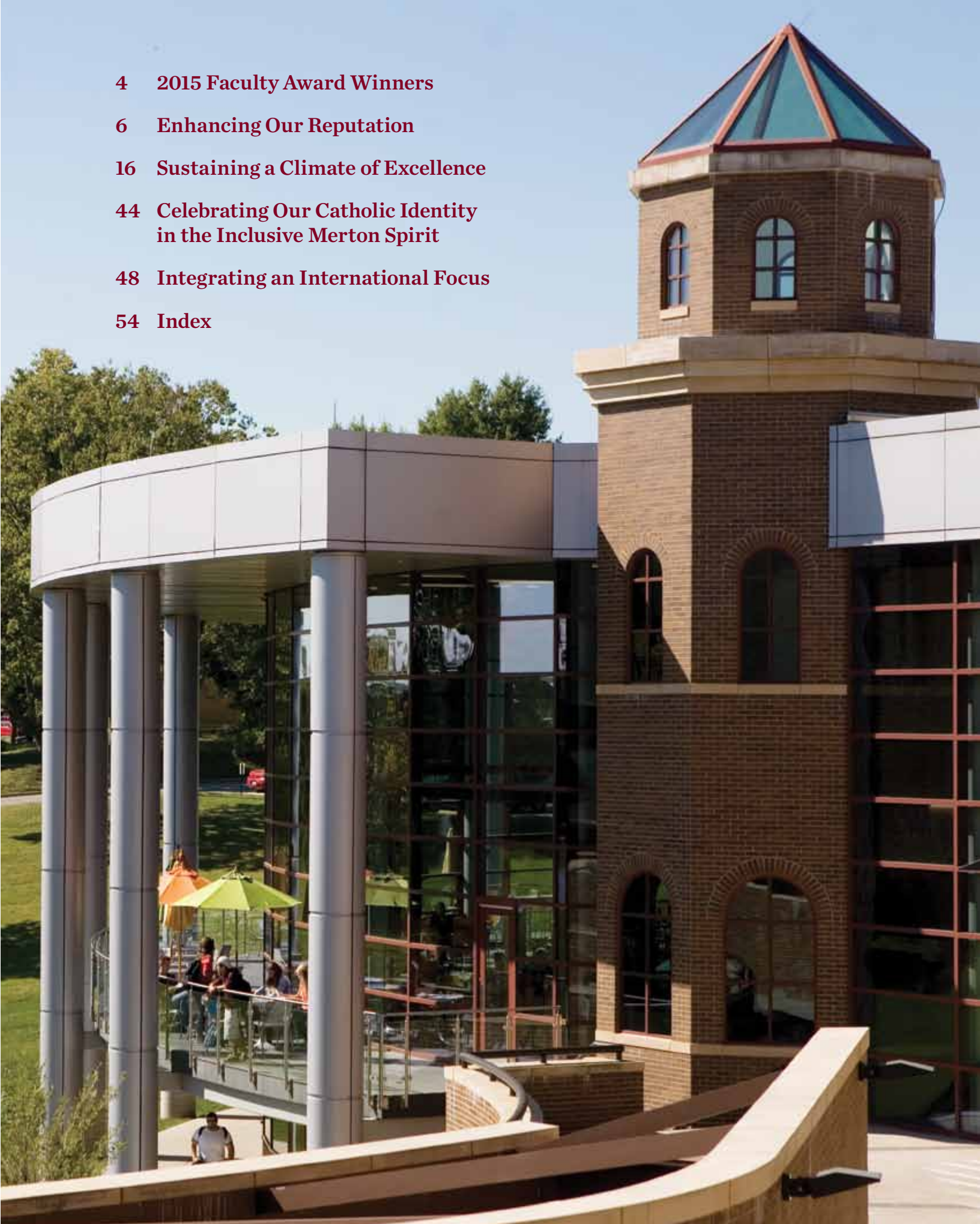

IN MEMORY

Dr. Tom Bennett (1950-2015)

Dr. Tom Bennett, professor of Biology, had a huge influence on the Bellarmine community for 36 years. His passion and dedication to his students and his work were unparalleled. His great stories during lectures helped students remember content, and he connected the lecture material to lab exercises as a way to reinforce both. He had a major impact on the local medical field through teaching future nurses and doctors and through his many years as chair of the Pre-Med Advisory Committee. One of his greatest loves was traveling to the Bahamas over Spring Break to educate students on tropical marine biology. Dr. Bennett's studies of human physiology reached a peak with his experiments that flew on the NASA Space Shuttle Discovery. His dedication to Bellarmine was demonstrated by his work as founding president of two governance systems: the Faculty Assembly in 1992 and the Faculty Council a decade later. Dr. Bennett never missed a men's home basketball game. His absence from Knights Hall, and from the entire campus, will be felt by all.



Dr. Richard Schrader (1953-2015)

In more than 16 years at Bellarmine, Dr. Richard Schrader, professor of Accounting, served the university in a variety of official capacities—as a teacher of financial accounting, theory and MBA classes; as chair of the Accounting Department; and as assistant dean of the W. Fielding Rubel School of Business. His colleagues noted his leadership skill and his ability to maintain a focus on excellence. “He was one of the best Accounting Department chairs we have had,” one said. His students, meanwhile, counted themselves fortunate to have a professor who not only educated them, but cared about them. “I am deeply saddened by the loss of Dr. Schrader. I cannot express how highly I thought of him and how lucky I feel to have had the chance to learn from him,” one student said. “He was not just a teacher but a mentor as well.” Fair, kind and supportive, Dr. Schrader was not just a colleague, but also a friend. He will truly be missed, but his influence will be felt in the School of Business for years to come.

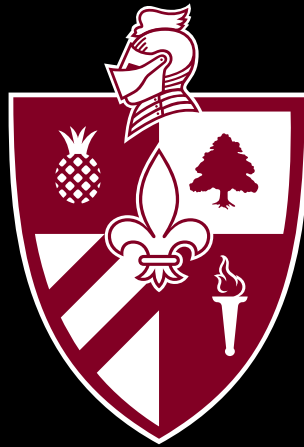

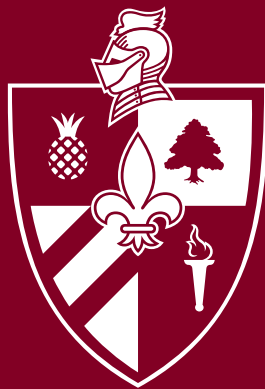
