## Career Readiness Competencies

The career readiness of college graduates is an important issue in higher education, in the labor market, and in the public arena. Internship experiences are constructive ways for students to develop in-demand professional skills. At Bellarmine, students are evaluated at the end of their internship experiences based on eight competencies identified by the National Association of Colleges and Employers (NACE).

#### These competencies are:

- Career & Self-Development
- Communication
- Critical Thinking
- · Equity & Inclusion
- Leadership
- Professionalism
- Teamwork
- Technology

Career readiness is the attainment and demonstration of requisite competencies that broadly prepare college graduates for a successful transition into the workplace (NACE definition).

#### Best Practices for Faculty Sponsors

It is our vision to create a career ecosystem across campus integrating our shared priorities with diverse campus partners to advance the career success of Bellarmine students. Faculty play a critical role in cultivating growth and learning throughout the student's internship experience.

Here are some additional ways faculty sponsors can support student internship experiences:

- Ensure students register their internship course on Handshake
- Require students maintain an Hours and Activity Log
- Review student Performance Self-Evaluation and Site Evaluation Survey (via Blue)
- Discuss Intern Performance Evaluation Survey by Site Supervisor (via Blue)
- Encourage students to complete an Internship Reflection Paper to apply in-classroom learning to professional experiences

#### **Faculty Sponsor FAQs**

## How can a student register for an internship experience for academic credit?

All internship registration occurs through Bellarmine's career management site, HANDSHAKE. Students complete an online application. The student's faculty sponsor, program chair and dean are notified electronically to review the online application and internship proposal. If you request changes to the student's proposal, send an email to the student and copy Career Development, who will update any requested changes to the application in Handshake. Once approved, the proposal is processed through the Registrar and the student is enrolled in the internship course for credit.

## What if a student asks to change internship sites in the middle of their internship experience?

Be sure to check the accreditation guidelines for your department as generally, a minimum of 90 hours (for 3-credit hours) must be completed at the same internship site location. If a change is permissible, notify the Career Center and speak with the student to understand why the change was requested. Not only is this a learning opportunity for students to work through challenges in workplace settings, but also this helps the Career Center manage employer partnerships with the university.

#### Are all internships paid?

Not all internship experiences are paid, but special attention must be considered to ensure all employers are abiding by fair labor standards. For more information, please refer to the U.S. Department of Labor, Fair Labor Standards Act (FLSA), which establishes minimum standards for student internship experiences. Please refer students to the Career Center to review special funding opportunities for internship experiences.

#### How does sponsoring a student internship experience impact my course load?
