My experiences as superintendent were focused on three priorities that I consistently communicated: 1) Ensure the learning of EVERY student, 2) Build the capacity of EVERY professional in our organization, and 3) Build partnerships in order to bring in resources to support the first two priorities

- Initiated and oversaw the development of programs focused on meeting the needs of diverse and atrisk learners—Reading Academy, Camp Literacy Live, restructuring of the ECE department
- Developed partnerships with significant stakeholders to expand opportunities for our students and staff—Bellarmine (Reading Academies, K Cohort, Preschool Cohort, Ed.S program for aspiring

administrators), U of L-A&S and Speed, Sullivan

- Initiated and oversaw the development of the Next Generation High School Academy to provide state of the art educational opportunities in the fields of engineering and biomedical sciences
- Worked with the board of education and district staff to correct a \$5 million budget deficit by raising taxes and cutting \$3 million in expenses.
