## II. President's Update - 11/19 at 3PM with Q&A on 11/21 at 11am

- a. Shelby mentioned a positive note on leadership looking into rightsizing employees and dropping unnecessary workloads.

- c. Jenny confirmed there will be no changes regarding FLSA in January
- d. Andrew mentioned executing early staff retirement is more difficult than faculty early retirement. Replacing staff is more challenging and costly.
